Whitney Oaks Golf Course

Over the past few months there have been several incidents of late-night vandalism due to trespassing on the Whitney Oaks Golf Club. Privately-owned golf carts and electric bikes have been used to damage several greens, bunkers, and maintenance equipment. Though the Golf Club is separately owned by UAIC (United Auburn Indian Council) it's a neighbor and an enhancement to our community – if you hear or see something please call the Rocklin Police Department.

Please note that the cart paths are owned and maintained by the Whitney Oaks Golf Club and their use is limited to paid golfers only. Whitney Oaks residents are trespassing and creating safety hazards when using the cart paths as running, walking/dog walking, biking trails, or to travel the community in private golf carts. Additionally, fishing is prohibited in the Golf Club ponds. ■

Association Dues Payments

As of October 1, 2021, the United States Postal Service has stated that First-Class mail delivery will be intentionally delayed. First-Class mail will no longer be guaranteed within the usual 1-3 business day timeframe. It has been reported that mail will be delayed up to 10-12 days for First-Class mail delivery. With this in mind we do encourage homeowners to mail in your monthly dues payment early so that it is received before the 15th of month to avoid accruing a late fee. If you are set up with the bill pay system through your banking institution please keep in mind that these payments are mailed via USPS, setting up the payment early so that it does *arrive* on the 1st of the month will also ensure that a late fee is not accrued. ■

Placer County Water Agency

PCWA has announced that they have adopted an emergency water conservation regulation that prohibit the irrigation of non-functional turf at institutional (CII) properties. The Whitney Oaks Community Association is classified as CII. PCWA has identified the turf examples that do not fall under the definition of non-functional turf and therefore are an exception to the regulation.

- Turf used for human recreation, civic purposed, sports or play.
- Turf irrigated with canal water (water that is not permitted for use as drinking water).
- Turf on the same valve as at least one tree or perennial non-turf plantings.
- Residential turf unless it is a common are of a Homeowners Association.

Whitney Oaks Wildlife Notes

Whitney Oaks **coyotes** are not often seen since they are active mostly at night. Occasionally, though, one shows up during daylight especially during the early morning or late afternoon hours. One morning I spotted a coyote coming into our backyard by ducking under our backyard fence where an old irrigation ditch used to be. I watched it explore the yard for several minutes as if it was hunting for prey and then out it went. I was so mesmerized by the animal's boldness I didn't think to grab a camera. Then, one evening recently Marti and I saw one on the golf cart path leading to the 10th tee. Just last year she spotted one on the hillside near the pond by the big Clubhouse loop. A friend who lives by that pond told me he occasionally sees coyotes boldly walking down the street in front of their house.

Coyotes are considered the most vocal of all North American mammals. Frequently, Marti and I hear them at night on the golf course. Their siren-like eerie howling discloses their presence to other coyotes in the area. Sometimes at night we are awakened by a rapid volley of yips, whines, screams and barks that sound like a large group of them having a not so friendly meeting. When our bedroom windows are open it can be somewhat alarming and unsettling. I have read that usually it's just two or more animals greeting each other and expressing their dominant or submissive social status.

Coyote pairs are territorial. Territory size is often dependent on the availability of their food supply. I would be very surprised if Whitney Oaks harbors more than one or two adult mated pairs and their young, born each spring. The mating season is between January and March and litter size is typically three or four pups.

Coyotes and foxes don't mix. I have never seen a fox in Whitney Oaks even though they are common in surrounding areas.

Coyotes are great rodent predators. That's the good news. Unfortunately, they have a liking for domestic cats so be careful about letting your cat roam outdoors at night. One homeowner told me their two cats survived only two weeks after moving here. They didn't know about the danger posed by Whitney Oaks coyotes to their pets.

I have never obtained a photo of a coyote in Whitney Oaks but when I was a docent at the Maidu Museum and Historic Site in Roseville, I got some photos of coyotes with a motion detector trail camera. One mated pair living in the fields and woods at the site housed their young in a big hollowed-out tree stump. The photos below were taken at that time.
