#### **Association Vendors**

#### Parking in the Association

Parking is not permitted on the street in the Association between the hours of 12:00 a.m. to 6:00 a.m. Short-term parking variance requests can be made via management. Please be sure that your request is made in writing and e-mailed to mikki.cooper@managementtrust.com, a minimum of 24 hours prior to your needs. Please also note that the management office hours of operation are from 9am – 4pm Monday through Friday. If you are making a request for Saturday or Sunday, please ensure that the request is received before close of business on Friday. For longer-term requests, please be sure to complete a parking variance request form at <a href="https://whitneyoaks.org/documents/">https://whitneyoaks.org/documents/</a>. Please be sure to follow the instructions on the form and submit photos with your request.

Parking variances will not be permitted for boats, trucks, vans, house trailers, campers, recreation vehicles or other vehicles containing living quarters. Vehicles such as these may be parked temporarily in a driveway or in a street in front of the owner's lot for a period of not more than forty-eight (48) hours for the purposes of loading and unloading.

In an effort to limit parking for access to the schools surrounding the Association, parking on the private streets in the Hillcrest Community while school is in session or during a school event is not permitted. In order to enforce this restriction street parking on Hillcrest Drive, Western Way, Vivien Way, Pheasant Lane and Chasen Court shall be limited to a maximum of three (3) hours per day on school days and during school events.

# Whitney Oaks Wildlife Notes


The American robin is one of the most well-known and popular songbirds in America. It is the most abundant land-bird in North America and is the state bird of Connecticut, Michigan and Wisconsin. We seldom see them during the summer months in Whitney Oaks but they migrate in to spend the fall, winter and spring seasons with us. For those of you not familiar with robins they are a medium size bird with a conspicuous reddish-orange breast that is most prominent in the male (see photos below).

The American robin gets its name from the European robin which also has a reddish-orange breast. However, they are otherwise quite different in appearance. The American robin is a member of the thrush family while the European robin is a type of flycatcher.

In the spring, male robins sing to advertise their territory and to attract a mate. You are most likely to hear their songs in the morning or evening and on rainy days. After mating, female robins build a sturdy bowl-shaped nest of grass, leaves, sticks and mud in the forks of trees or large bushes. They also use man-made structures for the base of their nests such as the eaves or ledges of buildings. Females typically lay 3-4 turquoise-blue eggs which she incubates for about 14 days. After hatching both the female and male feed the young a diet of earthworms and other soft-bodied prey. The young leave the nest in about two weeks after which the parents continue to feed them for another three weeks or so. It is not unusual for them to raise two or three broods of young each year. New nests are constructed for each brood.

Male and female robins are fully monogamous during the spring breeding season but afterwards go their separate ways. They may reunite for the next breeding season only if they return to the same territory.

Their diet primarily consists of invertebrates (e.g. earthworms, caterpillars, grubs), fruits and berries. Our daughter and son-in-law have persimmon trees which the robins invade in large groups during the winter. They love the sweet juicy fruit (see photo below). Here in Whitney Oaks there are many trees that produce small berries. These trees are particularly attractive to robins when the berries ripen. I have read that robins have been observed exhibiting strange behavior after eating large quantities of fermented berries. However, I have yet to see an inebriated robin. Maybe someday!
