These exterior colors shall be used for homes within the Whitney Oaks Neighborhoods. Colors are not for the Springfield Community or Unit 39 and 44 (Abby Court, Sterling Drive, Kensington Drive and Lawton Court). Springfield Community is overseen by the Springfield ARC. Unit 39 and 44 have a different color palette.

ARC applications must be submitted for all proposed painting projects, this includes re-painting the same approved colors. If you would like to use a color that is not listed on the color palette, the Board of Directors may review for final approval or variance. This will delay your project - please plan accordingly.

The ARC meets every **third Wednesday of each month (no meeting in December)**. Completed applications must be submitted one week prior to the meeting. Applications received after the deadline will be reviewed at the subsequent meeting.

PAINT MANUFACTURER: Most paint colors and numbers are Sherwin Williams paints, and the highlighted colors are Behr. Other paint manufacturers can be used if the color matches these colors provided. If using a different manufacturer, paint samples from the approved manufacturer must be provided along with the other manufacturer's color. The colors between both manufacturers must match. **The committee may deny your application without providing this information.**
