#### **Common Areas**

Sometimes common areas are hard to distinguish especially in a detached condominium areas, Abby Court, Lawton Court, Kensington Court, and Sterling Drive.

Here are some things to consider:

- o If you see a weekly service provider (Bianco Landscape Management), chances are the common area landscaping is completed by the Association. Common areas may include locations in the front, back and side of your home, but will not include any areas or plantings in your fenced yard areas.
- o Making changes to common areas is prohibited. For example; adding gravel/stepstone paths, adding concrete, plant removals, plant additions. If you have installed these types of items in common areas, please remove them and restore the area to its original condition.
- o It is also wise to be mindful of where outside décor items like statues and pots are placed. Items placed in common areas may be damaged during vendor service.

#### Finance Chair – Whitney Oaks Homeowner's Association



Take Interstate 80 from Rocklin heading toward Auburn


Landscape Committee Springfield Homeowner

- Exit 119 C, Highway 49 South Placerville (Elm Street)
- Follow directional signs for Hwy 49 South Placerville
- About .5 miles down Hwy 49, note the "yellow" Auburn State Recreation Area sign
- Just past sign is the Murphy's Gate to Robie Point turnoff to park car & walk/hike
- Marker sign on the green gate Robie Point Fire Break Trail:
- Opportunity to walk/hike .6-, .8-, 2.6-, or 3-mile easy terrain with a wide trail!

35,000-acre Auburn State Recreation Area is home to a section of the Western States Trail Ride, "Tevis Cup" as well as the Western States Endurance Run that traverses the length from Squaw Valley to Auburn! Robie Point is near the end of the trail, at the top of a steep climb from the combined North & Middle forks of the American River.


About a 1 mile from Murphy's Gate toward Robie Point is a picnic table situated on the right side of the trail with spectacular views of the canyon and river below. Enjoy!

## Whitney Oaks Wildlife Notes Ed Price

Western bluebirds are abundant in Whitney Oaks. Much smaller than a robin, the male is largely cobalt blue on its head, back, wings and tail feathers and its breast is rusty-orange. The female's wings and tail feathers are blue but its head and back are mostly gray and its breast is pale orange. Pairs nest in the spring or early summer with the female doing most of the nest building. The female lays 2-8 unmarked pale blue eggs in each clutch and incubates them for 12 to 17 days after which they feed the nestlings for 18-25 days.

As I write this piece here in mid-July a pair are feeding their second brood of 5 young in a nest box we placed in our backyard. Being hole-nesters, bluebirds readily use nest boxes that can be purchased at any wild bird supply store. We have had one or two broods of bluebirds raised in our yard in each of the last 15 years. It's interesting and fun to watch the bluebird parents bringing food, mostly insects, to their young. Back and forth they go feeding their young all day long even on the hottest days.

Several years ago, I decided to add a second bluebird nest box in our yard thinking two pairs would produce more young than one. To my surprise I found that only one box is used at a time. Dominant breeding pairs consistently exclude a second pair from nesting at the same time even though the two boxes are 50 ft. apart. I didn't know they were so territorial. And interestingly, the same box is not always used for each nesting event over season or year. Your *Notice of Desire to be a Candidate* and your optional *Director Election Statement* (described below) must be received by the Association prior to 5:00 p.m. on Monday, September 20, 2021 (the "Nomination Deadline"). Each Member who meets the qualifications set forth below and whose *Notice of Desire to be a Candidate* is received by the Association prior to the Nomination Deadline shall automatically be a candidate. There shall be no nominations from the floor at the Annual Meeting and votes for write-in candidates shall not be valid. It is each Member's responsibility to confirm that such Member's *Notice of Desire to be a Candidate* was received by the Association prior to the Nomination Deadline.

#### Candidate / Director Qualifications:

- 1. Except as provided in Section 1.D of the Election Rules, in order to be eligible to become a candidate, a person must, as of the Nomination Deadline, be a Member who is current in the payment of regular and special Assessments.
- 2. Except as provided in Section 1.D of the Election Rules, in order to be eligible for election to the Board, a candidate must, as of the date scheduled for close of the balloting period, be a Member who is current in the payment of regular and special Assessments.
- 3. Only one co-Owner of a particular Lot/Unit may serve on the Board at any time.

#### **Director Election Statements:**

Each candidate and each Member advocating a point of view may, but is not required to, submit (to the addresses listed above) a *Director Election Statement* that is reasonably related to the election. *Director Election Statements* shall not, when printed, exceed one side of a single 8½" x 11" page. Black and white copies of all *Director Election Statements* that are received by the Association prior to the Nomination Deadline will be included

with the *Ballot Packets* that will be mailed to all Members and may be posted on the Association's official internet website, in accordance with the Association's Election Rules.

By submitting a *Director Election Statement*, you accept full responsibility for its content and agree to indemnify the Association and its agents and representatives for any and all damage arising from or related to any such content. It is each Member's responsibility to confirm that such Member's *Director Election Statement* was received by the Association.
