

clearance, weight reduction and cutting away dead or overgrown branches or stems to promote healthy plant growth. Health maintenance includes injections to certain trees in need of liquid fertilizer and fruit reduction.

Tree-of-Heaven is a native out of China, fast growing, deciduous, exotic invasive tree that is able to germinate and grow in a wide variety of soil and site conditions and is troublesome from urban landscapes to woodlands. It can reach a height of 80 plus feet tall and has become naturalized in most if the United States. These trees are a problem in the Hillcrest Community and are scheduled for spraying. *All materials used for fertilization or spraying is soil injected and/or directly applied so toxicity for pets and people are not an issue.*

Once the annual tree trimming is completed, requests for additional pruning will be held until the next annual pruning date, unless considered a health and safety risk by a professional arborist. *The crew will be in the area for approximately three (3) weeks beginning March 4th*.

Grazing: Whitney Oaks is Happy to have CAPRA Environment and their lovely goats back again this year, it almost feels they just left. Grazing is scheduled for

mid-March. This year we are going to work on setting up a baby goat and lamb day for the community. There will be bottle fed baby goats for the family to enjoy and interact with. We will send out an email notification and post the dates/times online once they have been established. **Have**
